

**MIAMISBURG MUNICIPAL COURT – TRAFFIC SAFETY PROGRAM (TSP)**  
**DEFENDANT'S ACKNOWLEDGEMENT AND AGREEMENT**

1. I have read and reviewed the **Miamisburg Municipal Court Traffic Safety Program (TSP) Terms and Conditions.**
2. I understand that to be eligible for the Program the following minimum requirements apply:
  - (A) The traffic case does not involve a crash with property damage or personal injury.
  - (B) Defendant must not have a Commercial Driver's License (CDL).
  - (C) Defendant must not have participated in a similar program within the last 2 years.
  - (D) Defendant must have a valid driver's license and automobile insurance coverage.
  - (E) The citation is for a 2-point minor misdemeanor traffic violation with no companion criminal charges.
3. I understand that to complete the Program, I am required to complete these steps:
  - (1) Sign this Acknowledgement and Agreement.
  - (2) Sign the Conditional Guilty Plea, admitting my guilt to the traffic offense.
  - (3) Pay the \$200 Program Fee to the Court and pay the **\$24.95** to the traffic class.
  - (4) Complete the on-line traffic safety class at [safedriveronline.com](http://safedriveronline.com) before the date provided by the court.
4. I understand that after I complete the class, the Court will dismiss the case and no points will be assessed to my driver's license record.
5. I understand that if I do NOT complete the Program, the Court will impose a fine and court costs, which I must pay within 30 days of the Court's notification.
6. I understand that if I do NOT pay the fine and court costs within 30 days, the Court will issue a warrant block against my driver's license.
7. I understand that the Program Fee of \$200.00 is NON-REFUNDABLE.
- 8. I understand that I am responsible for taking this on-line program at safedriveronline.com paying the \$24.95 fee**
9. I understand that the class is provided by a third party, and that all scheduling and refund policies for the class is at the discretion of the class provider, and NOT the Court.
10. I understand the Court will NOT grant any time extensions.

**CONDITIONAL GUILTY PLEA AND TIME WAIVER**

1. The Defendant admits guilt to the offense charged.
2. The Defendant knowingly and voluntarily waives his/her right for a Trial to be held within 30 days.
3. The Defendant knowingly and voluntarily enters a conditional Plea of Guilty, and understands that after completing the Traffic Safety Program, the Court will Dismiss this case.
4. The Defendant acknowledges that failing to complete the Program will result in a finding of Guilty and a Judgment of Conviction against the Defendant, imposition of a fine and court costs, and the assessment of points against the Defendant's driver's license.

**ENTRY AND ORDER**

1. This Court finds the Defendant is eligible to be screened for the Traffic Safety Program.
2. This Court finds the Defendant knowingly and voluntarily admitted guilt to the offense charged.
3. This Court finds the Defendant knowingly entered a conditional Plea of Guilty
4. This Court finds the Defendant knowingly waived his/her right to a Trial to be held within 30 days.
5. This Court hereby stays its finding of Guilty and stays the imposition of fines and court costs.
6. Upon Defendant's completion of the Program, the Court shall Dismiss this case.
7. If the Defendant fails to complete the Program, the Court shall enter a finding of Guilty, impose a fine and court costs, and submit this conviction to the Ohio BMV.

### Introduction:

The Miamisburg Municipal Court gives you the opportunity to have your case dismissed and avoid points on your license if you complete the Safe Driver Online program. This means no points go on your license, and your insurance rates are unlikely to go up as a result of your ticket. By requiring each participant to complete the Safe Driver Online program, the Miamisburg Municipal Court seeks to promote safe driving and ensure the streets are safer for everyone.

### What's next:

1. Speak to someone in the Clerk's office to determine if you are eligible for the program. Most drivers are eligible.
2. Let the court know that you plan to participate in the program.
3. Go to [SafeDriverOnline.com](http://SafeDriverOnline.com) and purchase the course for \$24.95.
4. Complete the course. It takes about 2 hours. You don't have to do it all at once; you can do part and then pick up where you left off. You can use a computer, tablet, or smartphone.
5. One business day after you finish the program, Safe Driver Online will send your certificate of completion to the Miamisburg Municipal Court and your case will be dismissed. You won't need to file anything else with the court.

### Other Important Info:

- You have 60 days to complete the program. *No extensions will be granted.*
