TWELVE POINT SUSPENSION O.R.C. §4510.037 – §4510.038

What is it?

When you have accumulated twelve (12) or more points against your Ohio driver's license within a two year (2) period, the Ohio Bureau of Motor Vehicles is required to send you a notice at your last known address imposing a "Twelve (12) Point Suspension" of your license. The suspension is a class D suspension, which lasts for a period of six (6) months, effective the 20th day after the mailing of the notice.

During the twelve point suspension period, the State of Ohio allows you to petition for limited driving privileges through the Court that has jurisdiction over where you live. Before applying for limited driving privileges, you must also meet the following requirements:

- 1. You must complete a one-day 8 hour remedial driving class. The class must be taken <u>after</u> the conviction date which caused you to reach the 12 points. (A list of approved classes is attached.)
- 2. You must file with the BMV proof of financial responsibility (FR) insurance coverage, which is also called SR 22 or bond insurance.
- 3. You must pay a \$40.00 fee to the BMV before you are eligible to re-take your written and driving exams.
- 4. You must re-take and pass the written and driving license exams through the BMV.

How to get Driving Privileges:

- 1. You cannot owe more than a \$500.00 balance to the Miamisburg Court; <u>OR</u>, if you do owe more than \$500.00, you must be placed on a Court approved payment plan, and have made your first month's payment.
- 2. Complete and file the attached "Petition for Limited Driving Privileges" and "Worksheet for Limited Driving Privileges" in the Miamisburg Court during regular business hours (Monday through Friday 8:00 a.m. to 4:00 p.m., except legal holidays).
- 3. You must pay a non-refundable filing fee of <u>\$125.00</u>. If you are under additional license suspensions, there is an additional non-refundable fee of <u>\$50.00</u> for each additional suspension. This fee must be paid in full when you file.

- 4. You must show the Court proof of financial responsibility (FR) insurance coverage, which is also called SR 22 or bond insurance.
- 5. If you owe a balance on your BMV reinstatement fee, you must have this paid in full; OR you must be placed on a payment plan for your BMV reinstatement fee through the Court that has jurisdiction over where you live. (There is a \$25.00 fee to petition the Miamisburg Municipal Court for a BMV payment plan.)

Court Procedure:

- 1. The Court will review your request to make sure you meet all legal requirements to receive limited driving privileges. The Court is not required to grant limited driving privileges, and may deny your petition based upon your driving record and other factors.
- 2. You are <u>not</u> permitted to drive until you receive the "Entry Granting Limited Driving Privileges" (also called your "Driving Letter") signed by the Judge.
- 3. It may take up to 3 business days to process your request. After filing your Petition/Application, do <u>not</u> contact the Court to see if it's done, unless you have not heard back from the Court in more than 3 business days after you file.
- 4. After receiving your "Entry Granting Limited Driving Privileges" (also called your "Driving Letter") signed by the Judge, you must keep this with you in your vehicle <u>at all times</u>, along with proof of insurance.
- 5. Warning: Should you drive outside the limits placed on your driving times and/or locations, or otherwise violate the terms of your driving privileges, the Court may choose to cancel your driving privileges.

Paper copies of SR-22/Bonds are generally processed within 72 hours of receipt. Although this time can be extended for various reasons, it is seldom Many insurance companies send the Bureau SR-22/Bond filings electronically. These filings are usually processed the same day that they are received. by law to notify Ohio if the policy cancels. Most of the larger insurance companies are licensed in Ohio and other states and can assist with the proper appropriate payment. The insurance company will then file the SR-22/Bond on behalf of the individual filing. The SR-22/Bond must be an Ohio SR-22/Bond, from an insurance company licensed to do business in Ohio. REMEDIAL CLASS INFO SHEET

Any person who has at least two, but less than twelve points, may take the remedial driving class. Upon the person's completion of the class, the person may apply for a two point credit/reduction on the person's driving record.

A person can take the class once every three years, but not more than five times during that person's lifetime.

If you have 12 points or more, you are placed under a 12 point suspension, and you are required to take the class for reinstatement.
